It is a physical barrier, similar to a speed bump, resulting in a quieter and safer street scene. It reduces frustration for service engineers, who, even at night, can immediately correct a fault. A tidy street is also beneficial for economic development. Furthermore, the product is environmentally-friendly due to the absence of solvents. In short, an innovative preventative approach that fits into CAS' policy of sustainability.

The product may have a modest effect on the surrounding area, for example on the shopping public, tourism, investors and the like.

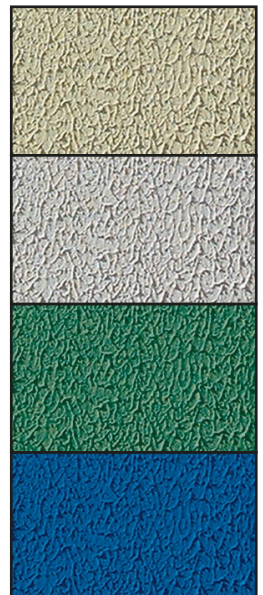


Discouraging illegal flyposting

The operation of this advanced system is remarkably simple. The surface of the treated object has a (bark) structure effect. People will not go to the trouble to put up a poster or other items on this surface; they will skip over the objects that are treated with the system.

The treatment

The surface is cleaned prior to the application of the coating by CAS specialists. All posters, graffiti and stickers are removed. Then the floor, locks and hinges and the like carefully covered with taped. The application of the coating is specialist work and is only executed by qualified and trained personnel. As the CAS Anti-Flyposter System is finished with a durable polyurethane varnish, removal of any graffiti is simple and thereby cost effective. After treatment, CAS Nederland B.V. gives a five-year warranty on the coating.

Maintenance contract

CAS Nederland B.V. optionally offers a maintenance contract for the periodic cleaning of the treated objects. Through this you are assured of the contribution to a clean streetscape and improved road safety.
